As courtesy info to you and Mr. O'Connell, the following was sent to each of the B.O. We urge you to vote against the proposal to allow commercial establishments in rural areas along Stringfellow Road on Pine Island.

The vast majority of the residents of Pine Island moved to the island because of its undeveloped, rural character. Lee County has recognized that strength and attempted to preserve and support it by allowing the island to have its own section of the comprehensive land use plan, which allows commercial development only in its four villages and Pine Island Center. That past support is very much appreciated and has resulted in Pine Island being unique among all developed islands off the coast of Florida.

It is our understanding that county staff has asked for and the LPA has agreed to, a recommendation from the Local Planning Agency to be rendered in August 2009. As residents of Bokeelia and members of the Bokeelia Civic Association we have not heard or had an opportunity to discuss the proposal. We assure you the president of the BCA misspoke when he said the proposal has the strong support of its members. My observation of the community is that the majority of support for the proposal comes from property developers and land speculators, certainly not from the majority of the residents of Pine Island.

Moreover the recommendation of the LPA will come without a public hearing and during the months when the population of Pine Island is at its lowest. If a hearing is held, it should be when the most people have a chance to be heard, i.e. December through March.
