In accordance with the provisions of <u>F.S.</u> Chapter 163.3184 and of FAC 9J-11.006, this submission package constitutes the transmittal of the proposed 2009/2010 Lee County Comprehensive Plan Amendment Cycle. The Local Planning Agency held public hearings for these plan amendments on the following dates: January 25; February 22; April 26; May 24; and, June 7, 2010. The Board of County Commissioners transmittal hearing for the plan amendments was held on June 16, 2010. The Board of County Commissioners voted to transmit the attached Lee Plan amendment package at the June 16, 2010 hearing. Per 9J-11.006(1)(a)(3), Lee County is requesting that the Department review the proposed amendments and provide an Objections, The proposed amendments are not Recommendations, and Comments (ORC) Report. applicable to an area of critical state concern. The Board of County Commissioners has stated its intent to hold an adoption hearing in October of 2010, after the receipt of the Department's ORC Report.
