The Lee County Board of Commissioners will hold a public hearing to consider an ordinance amending the Lee County Comprehensive Plan (Lee Plan) on Tuesday, December 14, 2010, in their Hearing Chambers at 2120 Main Street in downtown Fort Myers. The hearing will commence at 9:30 a.m., or as soon thereafter as may be heard. The purpose of the amendment is to adopt the 2010 Update to the Lee Plan Capital Improvement Element.

This meeting is open to the public. Interested parties may appear and be heard. Persons providing their name and address will receive a courtesy informational statement from the Department of Community Affairs prior to the publication of the Notice of Intent to find the plan amendment in compliance.
