Delete the sewage treatment plant and drain field, connect waste collection/transmission system to Lee County Utilities force main on Stringfellow Road and modify the private on-site lift station to pump project wastewater to Lee County Pine Island Regional Water Reclamation facility.

2) Miscellaneous Items.

Prior to any utility construction, please revise the plans and submit to LCU showing the followings design considerations:

- Please provide a note on all the utility plans that states "All on-site utility infrastructures to be privately owned and maintained."
- 2. Please revise the utility plan to relocate the proposed force main connection out from out from underneath the pavement and into open/green area. 5' from the back of curb/EOP.
- Revise the utility plan and profile of sheet 4 as it contains force main size conflicting information. Please address the proposed force main tapping sleeve and valve.
- 4. Prior to LCU's DO approval for the spray irrigation site, there must be a standard 20-year reuse agreement approved by the Board of County Commissioners.
- 5. A copy of the DEP permit for the proposed lift station and sewage force main.
- Please provide signed and sealed hydraulic computations and waste water model to LCU showing what impact this project may have on our existing sewer facilities.

Policies relate to traffic impacts and level of service and apply to rezonings and development orders (see Policies 14.2.1 and 14.2.2 and LDC Section 2-48).

The TIS must include an estimate of the number of trips that will use Pine Island Road from Stringfellow Blvd to Burnt Store Road to travel to or from this development.
