**NOTICE OF PROPOSED AMENDMENT TO THE LEE COUNTY COMPREHENSIVE LAND USE PLAN (ADOPTION HEARING)**

The Lee County Board of County Commissioners will hold a public hearing to consider the adoption of a proposed amendment to the Lee County Comprehensive Land Use

Plan (Lee Plan) on Monday, June 17, 2013. The hearing will commence at 9:30 a.m., or as soon thereafter as can be heard in the Board Chambers, 2120 Main Street in Downtown Fort Myers.

The Board proposes to adopt an ordinance amending the Lee Plan to reflect Federal and State requirements to reduce hazardous wildlife attractants on the Southwest Florida International Airport and Page Field General Aviation Airport properties (CPA2011-00022 - Port Authority Hazardous Wildlife Attractant Update).

This meeting is open to the public. Interested parties may appear at the meeting and be heard with respect to the proposed plan amendment.
