THE FOUNTAINS PUBLIC BENEFIT COMMITTMENTS May 2007

- 1. DR/GR **Improve groundwater recharge capabilities**, redirect surface water currently flowing to Lehigh Acres and Orange River, increasing hydrological connections to 6-Mile Cypress Slough, improve water quality meet or to exceed Outstanding Florida Water standards.
- 2. Conservation Areas Total 1,358 acres; 1,117 acres wetlands and 241 acres uplands, including **616 acres conveyed** to Lee County, contiguous to Conservation 2020 lands.
