We performed a site visit and checked the current enclosures at Partridge Place. According to my inspector there are 3 enclosures. She doesn't recommend enlarging them. It is a very narrow place and the driver would still have to roll the dumpsters out for service. We spoke to the hauler as well, and there are no issues on their side with the collection. We also see no issues with bulk collections. I think we can make an exception to the rule for this already existing community.
