My thoughts:

Consider revising the third sentence of Policy 1.4.4 as follows:

Uses permitted in this category include Campground Parks and Commercial and industrial uses that meet the standards in the Rural category.

The purpose of this (other than grammatical) is to make it clear that the Commercial and industrial uses must meet the standards in the Rural category (whatever standards that may include). Campground Parks would not be subject to that standard if drafted in this manner.

Suggested changes to the definition:

"Campground Park:" **Campground Park** is a recreational park located in non-urban areas geared towards camping and the enjoyment of the natural environment which consists of areas dedicated for tents and/or transient recreational vehicles, accessory recreational amenities, higher percentages of indigenous and general open space, and the minimum necessary infrastructure to serve the development.

Reference to campground in 1.4.1 would need to be revised to Campground Park.
