Amend Map 17: Southeast DR/GR Residential Overlay, to designate 1,460 +/acres along Corkscrew Road as an Environmental Enhancement and Preservation Community; Amend Lee Plan Maps
6 and 7 to include the property within the Future Potable Water and Sewer Service areas; and amend Policy 33.3.4
to allow Tier 1 properties with access to Corkscrew Road to extend the Overlay up to 2 miles south of Corkscrew Road in order to develop a residential community. The property is located approximately 4 miles east of Alico Road.
