





#### BOCC Objective:

To establish common procedures for informational meetings



Proposed Amendments:

- Procedures for all community informational meetings are provided in Goal 17 and deleted from individual community goals
- Meeting requirements for zoning applications are provided in the LDC
- ✓ Goal 17 also:
  - ✓ Provides a definition of a community plan: A Goal in the Lee Plan specific to a defined area of the county where long term objectives of the community, and policies to meet these objectives, are identified.
  - Provides objectives for development of community plans and community planning boundaries


### Part I Amendments - Overview

**BOCC Objective:** 

- To eliminate redundancies & combine similar provisions
- ➤To correct vague provisions
- ➤To relocate regulatory provisions from Lee Plan to LDC


Proposed Amendments:

- Remove explanatory & unnecessary language to clarify provisions






