Please vote YES on comprehensive land use change CPA 2019-00001.

Lee County has proposed amendments to the Lee Plan that would clarify the county's policy as it pertains to commercial/industrial development on land with impacted wetlands. These amendments codify 25-year-old unwritten policy that allows for construction of commercial/industrial buildings on sites with impacted wetlands, if granted a permit from the state.

As you know these amendments are now before the Board of Lee County Commissioners for consideration.

- Not adopting these amendments will effectively shut down commercial/industrial development causing the loss
 of jobs, new business development and county tax base.
- These wetlands are not critical to the protection of our water resources and flooding issues. New development requirements are not the problem! Water and flood control regulations provide great protection for the community.
- The state and federal wetland permitting processes are rigorous and can take up to 3 years. The county doesn't have the resources to review projects for impacted wetlands.
- The state and federal agencies have determined that the isolated wetlands found on these commercial/industrial sites have little chance for long-term sustainability. They recommend and support, through their rigorous review process, mitigating the impacts to these wetlands at off-site regionally significant locations such as the DR/GR.
- This mitigation, combined with county preservation, has led to the re-connection of sensitive flow ways and listed species habitat in the DR/GR.
- There is no direct link between filling isolated wetlands and red tide/blue-green algae.
- We do support and thank Commissioners for their efforts to balance growth with environmental protection, but not adopting these amendments is not the right answer.

ACTION ALERT: Tell Lee County Commissioners to Protect Our Wetlands

COTI has always defended the Sanibel Plan - our island's award-winning comprehensive land use plan. Increasingly, we are seeing the need to also defend the Lee County Comprehensive Plan so that the County does not continue down the path of overdevelopment, which has degraded the quality of life in the county. Overdevelopment on the mainland affects our islands in terms of water quality and congestion - during peak season, in particular, most of the automobile traffic on Sanibel consists of day-trippers, coming from an increasingly populated and developed mainland.

We need your help in convincing the Lee County Commissioners not to make changes to the Lee County Comprehensive Plan's protection of wetlands. Changes being considered (for transmission to the state) on May 22 would amount to the County giving away authority to regulate the use, density, and intensity of development on wetlands by allowing them to be developed at the same level as adjacent uplands.

This is not consistent with Lee County's recognition of the critical nature of wetlands for stormwater management, flood control, and water quality.

The proposed changes to the Lee County Comprehensive Plan would encourage wetland loss, at a time when the County should be encouraging the preservation of wetlands. The entire issue of wetlands protection in the County Comprehensive Land Use Plan should be considered further by County staff before such far-reaching and potentially harmful changes are adopted.

For that reason, we ask that you email the county commissioners and urge them not to transmit Comprehensive Plan Amendments 2019-00001 to the state until a comprehensive review of the issue by staff is completed and evaluated. The commissioners' email addresses are:
