Amend the Vintage Commerce Center Commercial Planned Development (CPD), consisting of 33.95± acres, to modify the Master Concept Plan, add an option to develop up to 308 multiple-family dwelling units, increase the allowable commercial and office to 350,000 square feet, modify the schedule of uses to add additional commercial uses, including 300 hotel units, assisted living facilities, hospital and miscellaneous retail office and light industrial uses, and revise development standards to allow a maximum building height of 85 feet. The development is proposed to connect to potable water and central sewer. Blasting will not be used in the excavation of lakes or other site elements.
