In accordance with the provisions of F.S. Chapter 163, this submission package constitutes the adoption of Comprehensive Plan Amendment known locally as CPA2019-0006. This amendment packet includes the final action and adopting ordinance for the following amendment:

CPA2019-00006 (Conservation Lands Map Amendment):

Amend the Future Land Use Map series, Map 1, by adding three County-owned properties to the Conservation Lands (Uplands and Wetlands) future land use category. **(Adopted by Ordinance 20-04)**

The Lee County Board of County Commissioners held an adoption hearing to adopt the above identified ordinance for the plan amendment on May 6, 2020. As required by F.S. 163.3184(4), the final action on this amendment was completed within 180 days of the receipt of the state land planning agency's report.

No additional changes were made to the adopted amendment that the State Land Planning Agency did not previously review.
