TITLE:

Amend the Lee Plan's Planning Horizon from 2030 to 2045

MOTION REQUESTED I.

Direct staff to amend the Lee Plan planning horizon from the year 2030 to 2045, consistent with Florida Statutes.

II. **ITEM SUMMARY**

Direct staff to update the Lee Plan planning horizon to the year 2045. This update is required to maintain consistency with state statutes and will authorize staff to analyze and draft necessary non-substantive amendments, which will then be considered through the full public hearing process. Amendments to the Lee Plan are not being approved by this action.

III. **BACKGROUND AND IMPLICATIONS OF ACTION**

A) **Board Action and Other History**

The Lee Plan is based on the Bureau of Economic and Business Research (BEBR) population projections. The 2030 Lee Plan horizon was adopted in 2006 by CPA2005-00025. The purpose of this amendment is to update the planning horizon to the year 2045 consistent with 163.3177(1)(f)(3) F.S. which requires the Lee Plan be based on at least a 10-year planning period.

The current Lee Plan is based on the 2030 BEBR population projection of 979,000 persons. BEBR projects a total population of 1,056,600 in Lee County by the year 2045.

If directed by the BoCC, the amendments would update Lee Plan text, maps and tables that relate to the planning horizon and which may also include non-substantive changes such as: updating references to regulatory citations and department and organization names; removing out-of-date requirements and policy directives for completed tasks; modifications necessary to reflect recent annexations and incorporations; and, reorganizing and renumbering as needed for clarity.
