In accordance with the provisions of Section 163.3184(3)(c)1., Florida Statutes, this letter is to provide notice to the Florida Department of Economic Opportunity ("DEO") and other state and regional review agencies of an agreement between the applicant, Small Brothers, LLC, and the County to extend adoption of Comprehensive Plan Amendment No. 20-003ESR (the "CPA").

The Lee County Board of County Commissioners held a public hearing to transmit the CPA on September 2, 2020. On April 6, 2021, the applicant's representative contacted the County via letter requesting a time extension for the second public hearing on the CPA until October 8, 2021, which was granted by Lee County and acknowledged by DEO. Dear Ms. Rozdolski:

Please accept this letter as notice on behalf of the applicant, Small Brothers, LLC, to allow a time extension for the adoption of the Comprehensive Plan Amendments, CPA 2019-00009, CPA 2019-00011 until April 8, 2022 (an additional 6 months) pursuant to Section 163.3184(3)(c)1., Florida Statutes.

The Lee County Board of County Commissioners ("Board") voted to approve transmittal of the CPA on September 2, 2020, and subsequently transmitted the CPA to the reviewing agencies on September 7, 2020. The Department of Economic Opportunity responded with no comments on October 9, 2020.

Pursuant to Section 163.3184(3)(c)1., Florida Statutes, the Board is required to conduct its second public (adoption) hearing to take final action on the CPA by April 8, 2021 (180 days after receiving no comments) or else the CPA would have been deemed withdrawn, absent an agreement to extend the deadline with notice to the Florida Department of Economic Opportunity ("DEO") and any affected person that provided comments on the CPA.

The applicant is working on the accompanying Planned Development Submittal consistent with the adopted text amendment and at the direction of Staff and the Commission. Due to other moving variables, including the Corkscrew Road widening, that affect the site plan, the adoption of the comprehensive plan amendment has been delayed allowing time for the property owner and the County to work together on addressing these issues.

Small Brothers, LLC is requesting that the County provide notice of this agreed time extension to DEO and any affected person that provided comments on the CPA.
