**Agenda Item #1, \*Call to Order, Introductions and Review of Agenda:** Mr. Al Giacalone called the meeting to order at 3:00 p.m. in the first floor conference room 1B of the Public Works/Community Development building at 1500 Monroe Street, Fort Myers and asked for introductions. A review of the agenda followed. **A motion to approve the agenda was made by Mr. Don Mayne and seconded by Mr. Eric Spivey. The motion was called; the agenda was approved as written.**

**Agenda Item #2: \*Approval of the June 16, 2021 meeting minutes. Mr. Mayne made a motion to approve the June minutes as written. Seconded by Mr. Spivey. Mr. Giacalone called the motion and it passed unanimously.**

**Agenda Item #3, Public Comments:**

There was no public present.

**Agenda Item #4(a): FGCU Walking Audits Presentation**

Mr. Giacalone recognized Ms. Jessica Marcolini, an instructor at Florida Gulf Coast University teaching about sustainability in the community. She reviewed a PowerPoint entitled "Sustainable Community Audits, Engaging Students in the Community" and talked about the class structure and the curriculum which was intended to engage the students in the topic of Urban Environments. Ms. Marcolini distributed an Urban Walking Audit, a series of questions designed to make students look more deeply at certain areas, reflecting on the safety, recreation, mixed use, and infrastructure in the area.

Following the presentation, there was a discussion about the uniqueness of downtown Fort Myers, the history of the area including references in *A Land Remembered*, a historical fiction book based on actual history, and a discussion about what happens with the audits and information once collected.

**Agenda Item #4(b): BPAC Resolution Revision Update**

Mr. Wagley provided some background information, stating that in 2015 because the committee was having trouble getting a quorum due to low membership, the resolution was changed to address quorum and some

other things. It was submitted to County Administration for review, but in 2017 the Commissioners discussed all advisory committees and any changes were put on hold pending further direction. More recently the BPAC Committee asked that the resolution be brought back for discussion. The language was reviewed, some changes were made with respect to dates, and a motion was made to send it on for review.

Mr Wagley reported that the DCD Manager had reviewed the resolution and it was sent on to County Administration for direction. He did not have an answer yet having been told that County Administration will need more time to consider exactly what authorization is needed in order to change the resolution.

**Agenda Item #4(c): MPO Update**

Mr. Ron Gogoi reviewed a Powerpoint which included Current Traffic and Crash Data. Shown was a seven month period for 2019, 2020 and 2021. For all except the Bicycle crashes, the numbers dipped in March and April 2020, the start of the pandemic with less cars on the road.

The Powerpoint also included information about the green 2 stage bicycle boxes at the intersection of Daniels and Treeline. Shown were before and after study analyses for total bike-ped activity at the intersection. Also a before and after study showing the use of the left turn lane versus crosswalk versus 2 stage left turn box. The after study analysis showed the majority of riders used the left turn lane versus the crosswalk and very few used the 2 stage boxes.

**Agenda Item #5(a): Garcia Ave and Figuera Ave Sidewalk Request**

This was a citizen request for sidewalk from Palm Beach Boulevard near the Tice Elementary School. It is within 2 miles of the school. The parameters would be Garcia Avenue from Figuera to Miromar, and Figuera from Palm Beach to Tice Street.

**Mr. Mayne made a motion to add this request to the BPAC list. Seconded by Dave Wheaton. There was no further discussion, other than the motion was to add these two sections as one project to the list. The motion was called and carried.**

**Agenda Item #6: Member Comments**

Mr. Spivey will be out of town September 15<sup>th</sup>, the date of the next meeting.

Dave Wheaton said he is now on the board of the Caloosa Riders. He plans to update them on the BPAC discussions when they meet.

Mr. Giacalone thought that Ms. Marcolini's presentation would be a benefit to MPO. Also with respect to Dr. Demers' concerns about not being able to do enough on BPAC perhaps MPO might be a better avenue. She was familiar with the MPO, had spoken with Commissioner Ruane a few months prior who recommended looking into one of the subcommittees, but she hadn't yet looked into that.

Dr. Demers gave kudos to DOT and RFA's. She continues to be impressed with how quickly they get things done. Mr. Wheaton said the same, mentioned street sweeping along Treeline and Ben Hill Griffin.

**Agenda Item #7: Staff Comments**

Mr. Wagley said there is a committee vacancy in District 3, Commissioner Sandelli's district. Anyone interested can apply online.

**Agenda Item #8: Other Government Entity Comments**

Mr. Gogoi said he understood that the MPO would be receiving funds from the infrastructure bill that was passed; it talks about complete streets, bike paths and safety.

There was a brief discussion about a new LeeTran Transfer Station in Lehigh. In general it is just north of Williams Park on Williams, north of Lee. Mr. Giacalone said BPAC projects gets points for being near a bus

stop, but asked if transfer stations are addressed differently. Mr Wagley explained that a transfer station would be counted as a bus stop, would get points for each route and for how many buses run per hour.

**Agenda Item #9: Upcoming meeting items**

Mr. Giacalone reminded the group that BPAC prioritization would be discussed at the next meeting. He suggested that everyone be prepared to talk about anything that they feel strongly about.

**Agenda Item #10: Adjournment**

Mr. Giacalone adjourned the meeting at 4:40 p.m.
