Agenda Item #1, *Call to Order, Introductions and Review of Agenda: Mr. David Wheaton called the meeting to order at 3:04 p.m in the Community Development/Public Works building, 1500 Monroe Street, Fort Myers, First Floor Conference Room 1B. Introductions were made. A review of the agenda followed. A motion to approve the agenda was made by Mr. Al Giacalone, seconded by Mr. Damon Shelor. Mr. Wheaton called the motion; the agenda was approved as written.

Agenda Item #2: *Approval of the March 16, 2022 meeting minutes.

Mr. Wheaton called for a review of the March minutes.

Mr. Giacalone pointed out three instances where Mr. Wheaton's name was misspelled and on the last page, that the motion maker for adjournment should have been Mr. Wheaton (not Mr. Giacalone).

Mr. Giacalone made a motion to approve the March minutes with those corrections. Seconded by Mr. Shelor. Mr. Wheaton called the motion and it passed unanimously.

Agenda Item #3, Public Comments:

Ms. Connie Speck, resident of Heritage Point on Pine Ridge Road spoke in support of a shared use path on Pine Ridge Road. This is already on the list but she wanted to reinforce the importance of a continuous sidewalk because of the continued growth of the area. Mr. Wagley pointed out that the Pine Ridge Road projects are #1, #6 and #9 on the Priority List and are the top three projects in the Southwest Road Impact Fee District.

Agenda Item #4(a) Iona Rd from Copra Ln to Intercoastal Ct Sidewalk Request

Mr. Wheaton reminded the committee that this sidewalk request had been made at the March meeting. There was a brief discussion concerning the points and that putting the project on the list separately would not benefit it since it would be at about the same place as the current project.

Mr. Giacalone made a motion to extend the lona Road project currently at Line #133, all the way to Copra

Lane. Seconded by Jessica Marcolini.

Discussion followed regarding the private sidewalk on the other side. It is on an apartment complex's property, was built prior to the requirement that sidewalks must either be built in county right-of-way, or provide an easement for the sidewalk, and therefore provides no public access.

Mr. Wheaton called the motion and it passed unanimously.

Agenda Item #4(b): Prather Dr from W of Baker Ct to Adele Ct Sidewalk Request

A presentation for this project in McGregor Isles was also made at the March meeting.

While reviewing this request, Mr. Wagley said the initial request, on the list since 2013, was scored incorrectly and should have included points for proximity to schools which would put it somewhat higher on the list. Current project would add points for completing a major thoroughfare and for crashes. The Homeowners Association is in favor of it. The road is county maintained in the neighborhood, McGregor is state maintained.

Mr. Giacalone made a motion to add the current request as an extension of the project already on the list at Line #124. Ms. Marcolini seconded.

Mr. Steve Jansen pointed out that the drainage easement the citizen referred to in the presentation is not county maintained but is a state easement. The citizen had recommended a specific design scenario but was told that the final design would be determined after the survey, and a review by the design crew and would be determined at that point. Mr. Giacalone had asked the citizen about putting the sidewalk on the north side and she responded that the neighborhood would not like that.

Mr Jansen said he lives in that area and questioned the need for a sidewalk on this local street where there the traffic isn't heavy. He suggested instead a focus on collector streets with high speed, high volume, and heavy pedestrian traffic. The main walking traffic is to Publix across the street and kids don't walk to the schools which are 2 miles away, but are bussed. He questioned some of the criteria upon which the point scoring was based. Mr. Wagley said the committee generally reviews the point scoring criteria in June of each year, but in the meantime would send a copy of the current point scoring system to the committee for their review.

Mr. Wheaton called the motion. The motion carried 4-2 with Mr. Jansen and Mr. Wheaton dissenting.

Agenda Item #5(a): May is Bike Month Resolution

Staff distributed a copy of the Resolution that was read at the 4/19/22 Board Meeting. Mr. Wheaton attended and made a brief presentation to the Board.

Agenda Item #5(b): MPO Update - none

Agenda Item #6: Member Comments

Mr. Giacalone confirmed that he was resigning from the committee and that this would be his last meeting. He advised the committee to keep up on the good work.

Mr. Shelor understood Mr. Jansen's thoughts on focusing on collector roads, however, Lehigh has few collector streets but many neighborhoods are highly traveled commuter routes, so neighborhood roads are very important and should not be forgotten. He thanked Mr. Giacalone for his service.

Mr. Wheaton also thanked Mr. Giacalone for his service and wished him luck in his next chapter.

Mr. Jansen asked about the point scoring system and suggested including a cost benefit when doing the analysis.

Agenda Item #7: Staff Comments

Mr. Farhan Butt said DCD and DOT staff were working on recalibrating the point scoring criteria. A few of the areas being looked at: vehicle crashes - currently does not make a distinction between vehicle crashes, pedestrian fatalities or fender benders. Looking at ways to tie in that data; traffic volumes – high traffic volume does not necessarily equate to high pedestrian volume; identifying lower income neighborhoods with respect to lack of auto-ownership and/or public transportation options. He did not have a firm estimate of when a draft would be ready but hoped for mid-June.

Mr. Wagley thanked Mr. Giacalone for his service saying he will be missed. He also thanked the committee for being valued team members and each bringing something different to the table. He welcomed Mr. Jansen, recently retired DOT traffic engineer; Jillian Scholler, new to the traffic engineering department who is working to make the county safer and more efficient, and Farhan Butt who has a strong transportation planning background.

Agenda Item #8: Other Government Entity Comments

Mr. Jorge Puente of LeeTran reviewed the changes he mentioned at the last meeting which was a service change to the bus & tram routes on April 28th. Ridership has increased dramatically, probably in part due to rising gas prices and good customer service. The Bonita Mobility on Demand (MOD) has been running since February and has been doing well, so much so that a third bus is going to be added. Looking at adding this service to Lehigh and to North Fort Myers but are waiting on major infrastructure projects, such as completion of Rosa Park and construction of a bus transfer station in Lehigh.

Mr. Jansen asked whether there has been any thought to adding bike lockers at bus stops. Mr. Puente stated that Dawn Huff is the supervisor for security issues and he would check with her and let him know.

April 23rd is ride free day on LeeTran buses.
