Lee Plan Amendments

A, CPA2021-00015 Greenwell SR31

Amend the Future Land Use Map, Map 1A, to re-designate approximately 76.82
acres from the Rural and Wetland future land use categories to the Outlying Sub-
urban and Wetlands future land use categories. The property is located on the
east side of SR 31, approximately 0.25 miles south of North River Road, in the North
Olga Community Plan area.
