In accordance with the provisions of F.S. Chapter 163.3184(3) for Expedited State Review, please find attached the proposed Comprehensive Plan Amendments, known locally as CPA2022-00006 and CPA2022-00007 (Grand Bay). The amendments are as follows:

CPA2022-00006 (Map):

Amend Map 1-C to extend the boundary of the Mixed Use Overlay to the west side of S. Tamiami Trail, across from the intersection with San Carlos Boulevard, to include 15.64± acres.

CPA2022-00007 (Text):

Amend Lee Plan Policy 5.1.10 to align how density is calculated with how it is defined in the Glossary and with existing processes.

Both amendments were adopted by Lee County Ordinance 23-12.

The Lee County Board of County Commissioners held an adoption hearing to adopt the above identified ordinance for the plan amendment on June 7, 2023. As required by F.S. 163.3184(3)(c), the final action on this amendment was completed within 180 days of the receipt of the state land planning agency's report.
