# Diplomat House f/k/a North Diplomat RPD PD Amendment & Development Order Summary of Public Information Session

A Public Information Session within the North Fort Myers Planning Community was held on March 27, 2024 at 5:30 p.m., consistent with the requirements of Lee Plan Policy 17.3.5 Land Development Code (LDC) Section 33-1532. The meeting was held at the North Fort Myers Recreation Center, Room 102A, 2000 North Recreation Park Way, North Fort Myers, FL 33903.

The applicant was prepared to present the amendment to the planned development as well as the pending development order submittal for the project, however there were no attendees. The meeting remained open for thirty (30) minutes in case any attendees were running late.

Since LDC Section 33-1532 does not specify advertising requirements, Lee Plan Policy 17.3.4 was utilized and a notice was advertised in the Fort Myers News Press a minimum of 10 days prior to the meeting describing the project and providing contact information for questions or comments. No phone calls or emails have been received.



MOVEit Transfer is a third-party file transfer tool used by many organizations to support the transfer of data files. Between around May 27 and May 31, 2023, an unauthorized third party obtained certain files that were transferred through the MOVEit tool used by the firm. After being notified of the issue on October 26, 2023, Trilogy promptly coordinated with the firm to review the affected files to understand the nature and scope of the data impacted by the issue and notify affected individuals. The affected files contained personal information that had been obtained by the firm in connection with a legal matter, including name, contact information, date of birth, Social Security and other government-issued ID numbers, financial account information, health information and health insurance information. The types of affected personal information varied by individual.
