In accordance with the provisions of F.S. Chapter 163.3184(3) for Expedited State Review, please find attached the proposed Comprehensive Plan Amendment, known locally as CPA2022-00019 (Cary+Duke+Povia). The amendment is as follows:

## CPA2022-00019, Cary+Duke+Povia

Amend Lee Plan Maps 4-A and 4-B to include ±788.97 acres on the Lee County Utilities Future Water and Sewer Service Areas. The property is located on the south side of North River Road, approximately one mile east of the intersection of North River Road and SR 31.

The Lee County Board of County Commissioners adopted Lee County Ordinance 24-06 for the Plan Amendment on March 20, 2024. As required by F.S. 163.3184(3)(c), the final action on this amendment was completed within 180 days of the receipt of the state land planning agency's report.
