**Agenda Item #1: \*Call to Order, Introductions, Review of Agenda and Motion to Approve Agenda:**

Mr. David Wheaton, Chair, called the meeting to order at 3:17 p.m. in the Community Development/Public Works building, 1500 Monroe Street, Fort Myers, First Floor Conference Room 1B. Introductions were made.

**Mr. Wheaton asked for a motion to approve the agenda.**

**Mr. Derek Felder made the motion to approve the agenda as written, seconded by Mr. Paul Cohen. The motion was called and passed unanimously.**

**Agenda Item #2: \*Approval of the April 17, 2024, meeting minutes.**

Mr. Wheaton called for a review of the April minutes.

**Mr. Derek Felder made a motion to remove the last statement in Agenda Item #5 of the April minutes. The statement “It was decided that projects (b), (c), and (d) be added to the list as project (a) will be built by the developer.”, will be removed. These projects were discussed at the April 17<sup>th</sup> BPAC meeting, but whether they will be added to the list will be determined at today’s meeting.**

**This motion was seconded by Mr. Paul Cohen. The motion was called and passed unanimously.**

**Agenda Item #3: Public Comments:**

- (a) **Daniels Pkwy to Aeries Way Dr, and Daniels Pkwy down American Colony to Eagles Ridge –** Mr. Greg Lambrecht stated that along with Eagle Ridge there are five communities totaling over 1600 doors in the area. Mr. Lambrecht stated that since the April BPAC meeting, they’ve had two bicyclists run off the road with injuries, but no police reports made. He stated that this morning a bicyclist was hit by a car on Eagle Ridge Drive, with a police report being made. They have been on the BPAC list for a while now. What can they do to raise their level of importance on the BPAC list?

**Agenda Item #4: Bike/Ped Facility Requests/Presentations:**

- (a) **Summerlin Rd from Boy Scout Dr to Red Cedar Dr:**

Mr. Steve Jansen stated that the missing sidewalk along Summerlin is about 2500 feet. There is a bus stop and a few multi-family communities that are close by that could benefit from a sidewalk.

Mr. David Wagley shared that this project would score 77 out of 100 points. It would qualify as a Tier 1 project as it meets three out of the four criteria needed.

**Mr. Wheaton asked for a motion to add Summerlin Rd from Boy Scout Dr to Red Cedar Dr to the BPAC list.**

**Mr. Derek Felder made the motion to add this project to the BPAC list, seconded by Mr. Steve Jansen. The motion was called and passed unanimously.**

**(b) North Airport Rd from US 41 to Fowler St:**

Mr. Paul Benvie stated that a developer is building a Home Depot, and that part of the development order requires them to put in a sidewalk. Mr. Benvie shared that the developer may be interested in having the sidewalk extend past the RaceTrac to connect to US41.

**Mr. Steve Jansen made the motion to add North Airport Rd from US 41 to Fowler St to the BPAC list, seconded by Mr. Paul Benvie. The motion was called and passed unanimously.**

**(c) Arthur Ave East End Connection to LA-MSID Ringneck Canal Path:**

Mr. Brandon Kaczmarek stated that in Fiscal Year 2025/2026, Parks & Rec is budgeting to resurface all the sidewalks at Veterans Park, as well as add the extension of the sidewalk to Arthur Avenue if LA-MSIP has no objection to it. As soon as they can approve the funding and have communication with LA-MSID, they'll start the resurfacing and sidewalk.

**Mr. Derek Felder made the motion to dismiss consideration of Arthur Ave East End Connection to LA-MSID Ringneck Canal Path from the BPAC list based on the fact that Lee County Parks & Rec has this project in their maintenance plan. This motion was seconded by Mr. Paul Cohen. The motion was called and passed unanimously.**

**Agenda Item #5: Other Business**

**(a) MPO Update** – Mr. Ron Gogoi shared a presentation on the Comprehensive Safety Action Plan. Aside from this project, MPO is working on signs/billboards to display in the Palm Beach Boulevard corridor where there is a high transient population and many Spanish-speaking people that have been involved in accidents. Mr. Gogoi then reviewed the Recommended 2024 TALU and SU Multimodal Box Fund Priorities.

**(b) Presentation of BPAC Adopted Three Tier Point Scoring System** – Mr. David Wagley shared the new three-Tier point scoring system. The idea staff got from the BPAC committee was to find a way to prioritize the sidewalk requests as they come in prior to funding being available. They decided to come up with the three-tier program which mirrors the major road project point-scoring system. Everything in Tier 1 has funding provided. In Tier 2, three out of four criteria must be met. It must be within two miles of a school, or within half a mile of Transit. It must connect to an existing facility or one that's within a governmental plan. It must be either an arterial or collector or a local road with a minimum of 1200 cars a day. If there is a bike/ped crash with either a fatality or a serious injury, it will automatically be placed in Tier 2.

Mr. Rob Price added that the idea for the Tiers was to be transparent about the timing of these projects.

## **Agenda Item #6: Member Comments:**

- (a) Mr. Pat Connor stated that he wanted to make a motion based on some of the items talked about today.

Mr. Pat Connor made a motion that the BPAC committee move Project 31 *American Colony Boulevard Eagle Ridge* to Tier 1. The reason is due to multiple recent bicycle incidents, plus it will give the multiple communities safe access to bus stops and the Daniels Bicycle Pedestrian Extensive facilities. Mr. Connor then asked if he had a second motion.

Mr. David Wagley stated that items in Tier 1 are the projects that the County has already planned to fund.

Ms. Jillian Scholler stated that the most appropriate action would be to move the project to the top of Tier 2, making it next in line for funding.

Mr. Pat Connor said he would like to modify his motion, moving Project 31 *American Colony Boulevard Eagle Ridge* to the top of Tier 2. He then asked if he had a second.

**This motion was not seconded.**

A few members of the BPAC committee explained why they would not second Mr. Connor's motion.

- (b) Mr. Paul Cohen stated he heard a speaker earlier in the day and that they had talked about the growth plans for Lee County. He stated that they envision a reduction in cars about ten years from now. Mr. Cohen asked if there is any way that we could be kept advised, as he says it's nice that we're kept advised about things currently in place. What potential infrastructure changes are going to be coming? For example, Mr. Cohen heard that Daniels Pkwy could become an eight-lane road. Mr. Cohen stated that he would like to have current information on upcoming road and development projects.

Mr. Rob Price stated that development projects can be found online on the GIS site. Mr. Price stated that he has no problem spending 5 to 10 minutes presenting upcoming CIP projects the County has.

## **Agenda Item #7: Staff Comments**

- (a) Brandon Kaczmarek said there were no updates for Parks & Rec.

Mr. Derek Felder asked if there were any updates for the Able Canal.

Mr. Kaczmarek said they did get access to the easements, so they are just waiting to get a general contractor on board. It will be going to procurement soon. It's moving along.
